We are here today to continue an ongoing conversation on foreign aid reform. For the past 6 months, the administration has been busy laying the groundwork for a new development agenda. Experts agree that the strength of our development programs is directly linked to success or failure in frontline states like Afghanistan and Pakistan. They agree that USAID is more critical to achieving our foreign policy objectives than ever before, yet it lacks the fundamental tools, capacity, and expertise to fulfill its mission. They agree that too often decision makers lack basic information about the actual impact of our development programs, and they also agree that excessive bureaucracy and regulations and fragmented coordination are hampering our efforts to swiftly and effectively deliver assistance. And they agree that even as we plan for broad fundamental reform, there are many steps we can take in the interim to dramatically improve the effectiveness of our foreign aid efforts.
